- End-term examination for Autumn Semeter-2024 earlier scheduled to be held from 20th Jan, 2025 to 3rd Feb, 2025 as per the Academic Calendar issued vide endorsement No. Au/Acad/AC-Autumn-2024/2024/5308-38 dated 09-08-2024, shall now commence from 3rd Feb, 2025 to 20th Feb, 2025
- During the period of vacation wardens across all Faculties/Colleges shall ensure cleanliness/minor repairs (wherever necessary) of their respective hostels
