

The terms & conditions/reference for counselling shall be as under: -

- The candidates are required to attend, on their own expenses the Document verification/upgradation/Counselling on stipulated date/time and venue, failing which their candidature for provisional admission/upgradation shall not be considered in spite of having superior claim/merit.
- The seats shall be filled strictly as per prescribed eligibility in order of merit in UET -2024/10+2 qualifying %age marks as the case may be

- At the time of allotment of seat during the Upgradation/Counselling, the candidates shall have to pay in full & on-spot the prescribed semester/annual fee, as the case may be excluding Hostel Fee
- In case a candidate fails to deposit the requisite prescribed Semester/Annual fee, as the case may be, in full at the time of Counselling, he /she shall forfeit the selection /admission and the seat so forfeited shall be offered to the immediate next candidate in order of merit.
- Mere presentation of a candidate for upgradation/ Counselling, if called for, shall not confer upon him/her the right to admission/upgradation unless otherwise eligible.
- No Under Process Certificate in respect of any requisite document shall be entertained/accepted under any circumstance
- The candidate(s) who cannot attend the document verification on the scheduled date(s) can get their documents verified on the date(s) of counselling notified above. Such candidates shall to report SKUASAT-K, Shalimar by **9:00 A.M** positively
- The seat matrix shall remain available in the University website www.skuastkashmir.ac.in on 8th of October, 2024
- For admission against other states/NRIs categories, the candidates who have applied under fresh admission notice can only be considered for admission
- The Candidates are advised to regularly visit University website www.skuastkashmir.ac.in for other details/ updates and information in their own interest.

Note:- **Soon after the UG degree admissions get filled/complete across the Faculties/Colleges the process of counselling shall be declared closed forthwith.**
