It is hereby notified for the information of all concerned JK Domicile Category candidates that the 16<sup>th</sup> round of provisional seat allotment for admission to the B.Tech. (AI in Agriculture) Degree Programme against the available/vacant seats shall be conducted on 17.07.2026.

Subject to the availability of resultant vacant seats after completion of the 16<sup>th</sup> round, the 17<sup>th</sup> & 18<sup>th</sup> rounds of provisional seat allotment, if required, shall be conducted on 18.07.2026 & 19.07.2026, respectively.

Candidates are advised to regularly visit their respective dashboards on the SKUAST-K Admission Portal <https://skuastkashmir.in/IUMS/applicant/> for provisional seat allotment and other updates.

Candidates who are provisionally allotted seats in the respective round(s) shall be required to confirm/book their allotted seat by depositing a non-refundable seat booking fee of Rs.11,000/- (Rupees Eleven Thousand only) through the payment link available on their respective dashboards within the stipulated timeline.

Candidates are advised to check their dashboards regularly in their own interest. Non-receipt of any separate communication through e-mail or failure to access the dashboard shall not be accepted as a ground for any claim or request.

The schedule for Document Verification-cum-Counselling for candidates allotted seats in the rounds 1-18, shall be notified separately.

All other terms and conditions shall remain the same as notified vide this office Notification No. AU/Acad./U-09/2026/5650-59 dated 19.06.2026.

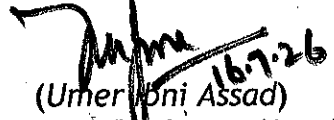
