It is hereby notified for the information of all concerned that the 2nd Round of Provisional Seat Allotment for admission to BHT/BAT courses for the Academic Session 2026-27 shall be conducted on 02.07.2026.

All candidates who were offered seats in the 1st round of counselling but could not book/confirm the same for any reason, as well as those candidates who have submitted/updated their programme preferences pursuant to this office communication No. Au/Acad/2026/B-03(IV)/5640-49 dated 19.06.2026, shall be eligible for consideration in the 2nd Round of provisional seat allotment.

The concerned candidates are, therefore, advised in their own interest, to log in to their respective Student Dashboards on the University Admission Portal (<https://skuastkashmir.in/IUMS/applicant>) on 02.07.2026 from 02:00 p.m. onwards and book/confirm their provisionally allotted seats by depositing the prescribed non-refundable seat booking fee of Rs. 6000/- within the prescribed timeline upto 05.07.2026 (11:59 PM).

Candidates who successfully book/confirm their seats shall be required to report for Document Verification-cum-Counselling on 07.07.2026 at 10:00 AM in the Conference Hall, Registrar's Office, SKUAST-K, Shalimar alongwith all original documents together with one set of self-attested photocopies thereof for verification. Failure to report on the scheduled date and time and failure to substantiate the claim(s) so made with requisite documents shall result in cancellation of the provisionally allotted seat.

No separate communication shall be issued in this regard.
