



Sub: Provisional allotment of seats, Document Verification-cum-Counselling thereof.

NOTICE

In reference to University Notification No.Au/Acad/BAT/BHT-2026/B-03(iv)/19861-99 dated 25.03.2026 issued regarding admission to the Basic Agriculture Training (BAT) and Basic Horticulture Training (BHT) Programmes for the Academic Session 2026-27, and in continuation of this office Notice bearing No.Au/Acad/2026/B-03(iv)/4180-84 dated 18.05.2026 followed by No.Au/Acad/2026/B-03(iv)/4500-05 dated 26.05.2026, it is hereby notified for information of all concerned candidates that the provisional seat allotment, based on merit/domicile(district) status/reservation/district preferences, submitted by the candidates, shall be made available through the University Admission Portal <https://skuastkashmir.in/IUMS/applicant> from **12.06.2026 (11:00 AM)** to **17.06.2026 (4.00PM)**.

Candidates shall access the portal using their registered credentials to view their allotment status. The allotted candidates shall also be provided a payment link through the admission portal/e-mail for non-refundable payment of Rs. 6,000/- (six thousand rupees only), comprising:

- i. Document Verification-cum-Counselling Fee : Rs.1,000/-
ii. Seat Booking Fee : Rs.5,000/-

The payment shall be made on or before 17.06.2026(4.00PM).

Candidates who book their allotted seats shall report to the Directorate of Education, SKUAST-K, Shalimar on **18.06.2026 at 10.00AM** along with all requisite certificates/testimonials in original and one set of self-attested photocopies thereof for document verification/counselling and completion of admission formalities.

The candidates shall also be required to deposit the balance fee of Rs. 15,000/- (fifteen thousand rupees only) on 18.06.2026 after document verification & confirmation of the seat, through online mode of payment only. The link for such payment of balance fee shall be made accessible to the candidates through the above portal only. Upon completion of admission formalities, the candidates shall be issued a Provisional Admission Communiqué for reporting to the allotted training centre.

NOTE: All seat allotments shall remain subject to verification of documents/testimonials and fulfilment of the prescribed eligibility conditions for admission to the programme. Any candidate who fails to substantiate the particulars furnished in the application form through valid documentary evidence at the time of document verification, or is otherwise found ineligible, shall forfeit his/her claim for admission and the provisional allotment shall stand cancelled at the sole risk and responsibility of the candidate concerned. Any seat so vacated shall be treated as vacant and may be included in the common pool for subsequent round(s) of counseling/upgradation, if required.
