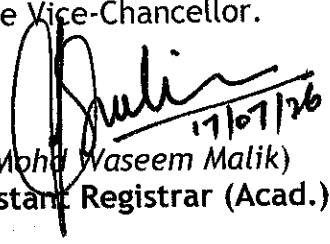

Subject: Revised guidelines for award of Gold Medal and provision for sponsorship thereof.

University Order No.15 (Acad.) of 2026

Dated: 25.02.2026

In pursuance of the approval accorded by the Academic Council in its 45th Meeting under Agenda Item No. AC-45 (01) {ATR-AC-44 (18-A)}, and in supersession of all previous orders issued on the subject to the extent of inconsistency, it is hereby notified that the revised guidelines for award of Gold Medal(s) to meritorious students of the University shall be implemented with immediate effect as under:

Undergraduate Degree Programmes:

One (01) Gold Medal shall be awarded for each Degree Programme.

Master's Degree Programmes:

One (01) Gold Medal shall be awarded for each Faculty/College, subject to a minimum enrolment of ten (10) students in the concerned programme.

Doctoral (Ph.D.) Programmes:

One (01) Gold Medal shall be awarded for each Faculty/College, subject to a minimum enrolment of ten (10) students.

In case the minimum prescribed number of ten (10) students is not available in any Faculty/College, the concerned programme shall be merged with the most related Faculty/College for the purpose of award of Gold Medal.

Relaxation in prescribed duration:

The minimum prescribed time period for completion of the degree for consideration of award of Gold Medal is hereby extended by one (01) semester.

Sponsorship of Gold Medals:

The University may approach or accept sponsorship from industrial or other external agencies for sponsorship of Gold Medals. Such medal(s) shall be over and above the university Gold Medal(s), for which the modalities shall be determined & notified separately.

Other terms and conditions as are in vogue for award / arriving at award of Gold Medal(s) shall remain unchanged.

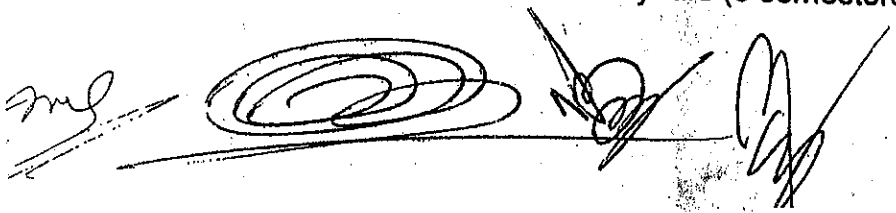

1. The Gold Medal shall be awarded to the 1st Position holders who has /have completed the entire degree programme of Undergraduate/Postgraduate degree programme within stipulated time period to be counted from the date of first registration upto date of issuance of Result notification as follows:

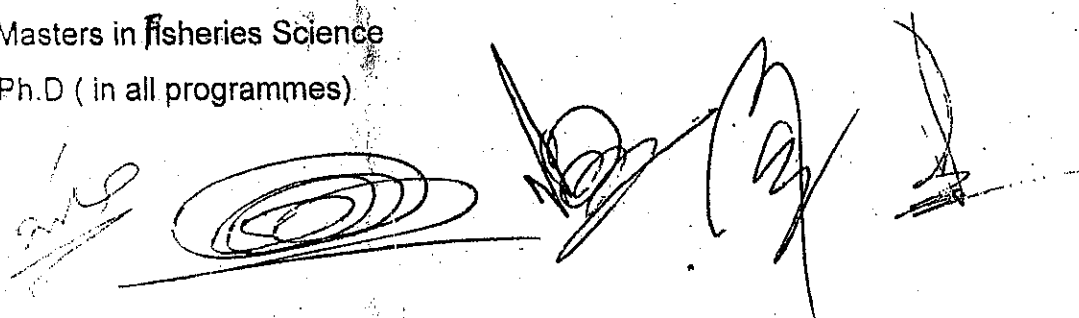

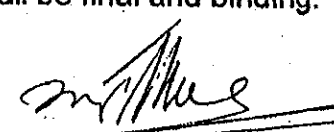
2. The Gold medal shall be awarded to the student(s) of various Undergraduate/Masters/Ph.D. degree programmes of the University and shall be awarded at the time of Convocation of the University.
3. The Gold medal shall be awarded to the students who secure the highest Overall Grade Point Average (OGPA) but not less than 8.00/10.00 point scale in respect of Undergraduate and 8.50/10.00 point scale in respect of Masters and Ph.D. Degree programme.
4. The Gold Medal shall be awarded to the 1st position holder of the following programmes:

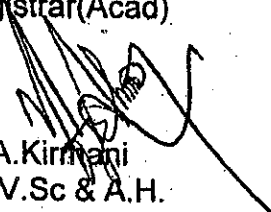

- ❖ B.Sc. (Sericulture)
- ❖ B.Sc. (Forestry)
- ❖ B.Sc. (Horticulture)
- ❖ B.Tech. (Agri. Eng.)
- ❖ B.F.Sc
- ❖ B.V.Sc & A.H
- ❖ Masters in Agriculture including Sericulture, Environmental Science, Agri. Statistics and allied disciplines
- ❖ Masters in Vety Science in all disciplines
- ❖ Masters in Forestry
- ❖ Masters in Fisheries Science
- ❖ Ph.D (in all programmes)

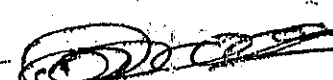


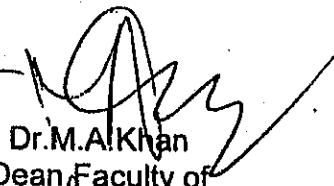

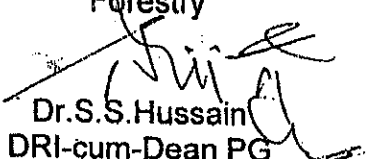
5. Student who has been on scholastic probation or who has been either restricted or expelled or on conduct probation or who has received any "F" grade in any of the courses shall not be eligible for award of Gold Medal.
6. Students who improve OGPA through supplementary examination or through any other means shall not be eligible for award of Gold Medal.
7. In case of two or more candidates obtaining the same OGPA and same number of credits earned, both the candidates shall be entitled for Gold Medal.
8. The Gold Medal shall be made of silver weighting 50 gms. with Gold plating.
9. The name of the students, the name of the programme and the year of successful completion of the programme shall be inscribed on one side of the Gold Medal and seal of University on the other side.
10. Deans of the Undergraduate/Postgraduate programmes shall recommend the name(s) of the students(s) for award of Gold Medals after strictly following the above norms to Registrar. The Registrar will screen the cases and submit the name(s) of student(s) to Vice-Chancellor for approval.
11. The Registrar after receiving the approval of Vice-Chancellor will notify the name(s) of student(s) awarded Gold Medal.
12. In case of any dispute or difference of opinion decision of Vice-Chancellor shall be final and binding.
