The appointment shall be governed by the following terms & conditions:

- The appointee(s) shall be on probation for a period of two years from the date of issuance of this order;

- ii. They shall have to qualify the ACC examination within the prescribed period of probation failing which their future increments shall be stopped till they pass the requisite examination;
- iii. During the period of probation, the appointment can be terminated by the University any time without notice or assigning any reason thereof;
- iv. The appointee(s) can be posted at any constituent unit of the University on equivalent post as and when required;
- v. The service conditions of the appointee(s) shall be governed in accordance with the SKUAST-K Statutes and the rules of the University as are in force or as may come into force from time to time and also the relevant provisions of J&K CSRs, as may be applicable;
- vi. If any declaration given or information furnished by appointee(s), proves to be false or any material information found to have been willfully suppressed, he/she shall be liable for removal from service and such other action as may be deemed necessary;
- vii. Other service conditions of the cadre in the Department of Finance, GoJK shall be applicable *mutatis-mutandis* to the Accounts Assistants of SKUAST-Kashmir.

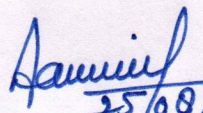
