As recommended by the Selection Committee, approved by Vice-Chancellor and in continuation to the Notice issued under endorsement No. AU/Adm(GAD)/Rec-AR-AC/26/3423-44 dated 20.05.2026, Mr. Malik Ayaz Ul Qadir S/o: Gulam Qadir Malik R/o: Pulwama-192301 is hereby appointed as Assistant Comptroller under Open Merit category in SKUAST-Kashmir on regular temporary basis, in the Pay Band of ₹15,600-39,100+GP of ₹5400(PR) revised to Level-10 of ₹56,100-1,77,500 of 7th CPC plus allowances as admissible under rules. He is adjusted against the post of Assistant Comptroller available at Comptroller Office, SKUAST-K, Shalimar.

The appointment shall be governed by the following terms and conditions, that:

- a) the appointee shall join on the post within a period of 21 days from the date of issuance of this appointment order, failing which, the above offer of appointment shall be cancelled without any further notice;
- b) the appointee shall be on probation for a period of two years from the date of joining on the post;
- c) during the period of probation, the appointment can be terminated by the University any time without issuing any notice or assigning any reason thereof;
- d) the appointee can be posted in any constituent units of SKUAST-Kashmir as and when required;
- e) the service conditions of the appointee shall be governed in accordance with the SKUAST-K Statutes and rules of the University as are in force with amendments or as may come into force from time to time, together read with provisions of J&K CSRs, wherever applicable;
- f) if any declaration given or information furnished by the appointee, proves to be false or it is found that the appointee has wilfully suppressed any material information, he shall be liable for termination from service and such other action as may be deemed necessary;
- g) if any document and/or certificate submitted by the appointee is found or proved forged or fake in any way at any point of time, the appointment shall be cancelled *ab-initio* at the risk and responsibility of the concerned;
- h) the appointee shall be required to submit Medical Fitness Certificate from the Competent Authority;
- i) if upon verification, to be received from the concerned issuing authorities, to whom a reference shall be made by the concerned office, the qualification certificate(s) and other documents, submitted by the candidate in support of his candidature are found to be fake/forged, the claim of the appointee for appointment as Assistant Comptroller shall be deemed to have been cancelled *ab-initio* and legal action as warranted under rules shall also be initiated;
- j) if the appointee has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre(DIC) and District Employment & Counselling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also the stakes, if any, in

- such self-employment unit/enterprise before joining the University service. He shall be required to repay the entire loan liability in suitable EMLs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit/enterprise and recovery to be made and shall also personally monitor its recovery;
- k) the salary of the appointee shall not be drawn and disbursed by the respective Drawing & Disbursing Officer unless a satisfactory report in respect of condition No. (i) above is received from the concerned authorities;
- l) the appointment shall be without prejudice to the outcome of writ petition(s), if any, pending before any competent Court of Law or the investigating agency




