- the appointee(s) shall join on the post within a period of 21 days from the date of issuance of this appointment order, failing which, the above offer of appointment shall be cancelled without any further notice;
- the inter-se-seniority of the appointee(s) shall be in the order, his/their name appear in the selection list, issued vide Notice under AU/Adm(GAD)/Rec-AR-AC/26/3423-44 dated 20.05.2026;
- the appointee(s) shall be on probation for a period of two years from the date of joining on the post;
- during the period of probation, the appointment(s) can be terminated by the University any time without issuing any notice or assigning any reason thereof;
- the appointee(s) can be posted in any constituent unit of SKUAST-K as and when required;
- the service conditions of the appointee(s) shall be governed in accordance with the SKUAST-K Statutes and rules of the University as are in force with amendments or as may come into force from time to time, together read with provisions of J&K CSRs, wherever applicable;
- if any declaration given or information furnished by the appointee(s), proves to be false or is found to have wilfully suppressed any material information, he/they shall be liable for removal from service and such other action as may be deemed necessary;
- if any document(s) and /or certificate(s) submitted by the appointee(s) is found or proved forged or fake in any way at any point of time, the appointment(s) shall be cancelled *ab-initio* at the risk and responsibility of the concerned;

- i) the appointee(s) shall be required to submit Medical Fitness Certificate from the Competent Authority;
- j) if upon verification, to be received from the concerned issuing authorities, to whom a reference shall be made by the concerned office(s), the qualification certificates and/or other documents are found to be fake/forged, the claim of the appointee(s) for appointment as Assistant Registrar shall be deemed to have been cancelled *ab-initio* and legal action as warranted under rules shall also be initiated;
- k) if the appointee(s) has/have taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre(DIC) and District Employment & Conselling Centre of the domicile District, he/they shall relinquish the proprietorship of unit/enterprise and also the stakes, if any, in such self-employment unit/enterprise before joining the University service. He/they shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/their salar(ies)y. DDO concerned shall obtain an affidavit from the concerned appointee(s) regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit/enterprise and recovery to be made and shall also personally monitor its recovery;
- l) the salary of the appointee(s) shall not be drawn and disbursed by the respective Drawing & Disbursing Officer(s) unless satisfactory report(s) in respect of condition No. (j) above is/are received from the concerned authorities;
- m) the appointment(s) shall be without prejudice to the outcome of writ petition(s), if any, pending before any competent Court of Law or the investigating agency.
