As recommended by the Selection Committee and approved by the Board of Management at its 72nd Meeting, and in continuation to the Notice issued under endorsement No. AU/Adm(GAD)/Rec-AP/26/5877-5903 dated 12.01.2026, Dr. Mohd Iqbal Yatoo S/o Gh Rasool Yatoo R/o Chadura, Budgam, Kashmir is hereby appointed as Associate Professor-cum-Senior Scientist(Veterinary Medicine, FVSc & AH) under Open Merit Category on regular temporary basis, in the Pay Band of ₹37,400-67,000 + GP of ₹9000/- revised to Level-13A of ₹1,31,400-2,17,100 of 7th CPC plus allowances as admissible under rules and adjusted against the post of Associate Professor-cum-Senior Scientist available at Div. of Clinical Veterinary Medicine Ethics & Jurisprudence, FVSc & AH, SKUAST-K, Shuhama.

The appointment shall be governed by the following terms and conditions, that:

- a) the appointee shall join on the post within a period of 21 days from the date of issuance of this appointment order, failing which the above offer of appointment shall be cancelled *ab-initio* without any further notice;
- b) the appointee shall be on probation for a period of two years from the date of joining on the post;
- c) during the period of probation, the appointment can be terminated by the University any time without issuing any notice or assigning any reason thereof;
- d) the appointee can be posted in any constituent unit of SKUAST-K, as and when required;
- e) the service conditions of the appointee shall be governed in accordance with the SKUAST-K Statutes and rules of the University as are in force with amendments or as may come into force from time to time, together read with provisions of J&K CSRs, wherever applicable;
- f) if any declaration given or information furnished by the appointee, proves to be false or the appointee is found to have wilfully suppressed any material information, he shall be liable for removal from service and such other action as may be deemed necessary;
- g) if any document and/or certificate submitted by the appointee is found or proved forged or fake in any way at any point of time, the appointment shall be cancelled *ab-initio* at the risk and responsibility of the concerned;
- h) the appointee shall furnish an undertaking executed before 1st Class Judicial Magistrate to the effect that patent rights in respect of the discoveries and inventions that are made and the technical and engineering "know-how" of processes that may develop during the course of their service, shall vest with SKUAST-Kashmir.

- i) if upon verification, to be received from the concerned issuing authorities, to whom a reference shall be made by the concerned office(under confidential cover), the qualification/experience certificate and/or other documents, submitted by the candidate in support of her candidature/API Score is/are found to be fake/forged, the claim of the appointee for appointment as Associate Professor-cum-Senior Scientist shall be deemed to have been cancelled *ab-initio* and legal action as warranted under rules shall also be initiated;
- j) the appointment shall be without prejudice to the outcome of writ petition(s), or enquiry, if any, pending before any competent Court of Law or the investigating agency.

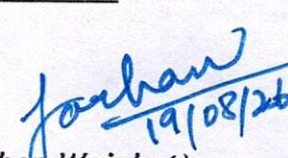
