



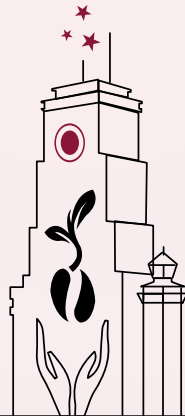



3	Farm Manager	Bachelor's Degree in Agriculture and Allied Sciences from a recognized University.
4	Assistant	Bachelor's Degree from a recognized University
5	Stenographer Grade-III	12 th class pass or equivalent from a recognized Board or University. Professional Efficiency: The candidates will be given one dictation test in English at 80 w.p.m. for 10 minutes. The candidates will be required to transcribe the matter in 50 minutes on Computer keyboard.
6	Driver	1. 10 th Pass from a recognized Board. 2. Possession of a valid "LMV-Trans" driving license from prescribed Government Authority. (The candidate will have to pass the practical skill test to be taken by an appropriate Committee) Desirable: 1. One year trade certificate in the relevant field from IT; or 2. Experience of driving in a recognized Institution; or 3. Experience of motor mechanic work.



Rs.700/- (Seven Hundred Only) per application Reserved Categories.
- Fee can be paid only online through Net Banking, Credit or Debit Cards.
- Applications received without the prescribed fee shall not be considered and summarily rejected. No representation against such rejection will be entertained. Fee once paid shall not be refunded under any circumstances not will it be adjusted against any other examination or selection.




Note:

- i) Apart from filling-up the Online Application Form, the **In-service candidates** are also required to submit/ send their Application Form(s) through proper channel, to Registrar, SKUAST-K, Shalimar, Srinagar, UT of J&K-190025 by or before 25th of May, 2026.
- ii) Applications received after expiry of last date of submission will not be accepted.

General Conditions:

- The mode of appointment, eligibility for the post, service conditions & other service benefits including Career Advancement etc. shall be strictly governed by relevant rules/ regulations of **Indian Council of Agricultural Research** and guidelines of the project scheme as are in force with amendments or may come into force from time to time. The appointee(s) shall be made exclusively for Krishi Vigyan Kendras (KVKs), and the appointees shall have no claim whatsoever for transfer or absorption the University's main establishment.
- The last date for receipt of Application Forms, as stipulated above, shall be the cutoff date for determining the eligibility for the post. Any qualification/experience acquired thereafter shall not be considered.
- The application will be accepted in the prescribed format in online mode through University website www.skuastkashmir.ac.in only. No other means/mode of application will be accepted.
- The applicants shall carefully fill the details in the online application form and the information /details so submitted shall be treated as final for the purpose of determining eligibility of the candidate and no claim, whatsoever, on this account, shall be entertained subsequently.
- Reservation for various categories shall be applicable in accordance with the provisions of Jammu and Kashmir Reservation Rules 2005 as amended from time to time.
- A candidate seeking his/her consideration under any reserved category must be in possession of valid category certificate as on the cutoff date of the submission of online application forms. Category certificates issued after the cutoff date shall in no case be entertained.
- Only relevant qualification(s) including category status etc. should be recorded in the Application Form, which shall be in possession of the candidate on or before the last date for receipt of Application Form.
- Canvassing by any candidate in any form will render him/her disqualified for the post.
- The original certificates and testimonials in possession of the candidate on or before the last date of receipt of Application Form(s) together with print out copy of application form submitted online shall be required to be produced by the applicants at the time of verification of documents, as and when notified by the University.
