Subject: Re-opening of Admission Portal for Submission of Online Application Forms for Master's and Ph.D. Degree Programmes (Autumn Semester-2026)

NOTICE

In continuation to Admission Notification No.Au/Acad/UET-PG(Autumn)/2026/P-17/3047-99 dated 11.05.2026 read with No.Au/Acad/UET-PG(Autumn)/2026/P-17/4539-89 dated 26.05.2026 issued regarding admission to various Master's and Ph.D Degree Programmes for the Academic Session 2026-27 (Autumn Semester-2026), it is hereby notified for information of all concerned that, pursuant to approval of the Competent Authority, the eligibility criteria prescribed for different categories of candidates has been revised.

Accordingly, the earlier category-wise eligibility criteria prescribed separately for Domicile, NRI-Sponsored and Other States/UT category candidates, deemed discriminatory, shall stand modified, and a uniform minimum eligibility criterion shall now apply to all categories of candidates.

The revised minimum eligibility criteria shall be as under:

Master's Degree Programmes:

- Domicile Category Candidates: 6.00/10.00 OGPA (or equivalent)
- NRI-Sponsored Category Candidates: 6.00/10.00 OGPA (or equivalent)
- Other States/UT Category Candidates: 6.00/10.00 OGPA (or equivalent)

Ph.D Degree Programmes:

- Domicile Category Candidates: 6.00/10.00 OGPA (or equivalent)
- NRI-Sponsored Category Candidates: 6.00/10.00 OGPA (or equivalent)
- Other States/UT Category Candidates: 6.00/10.00 OGPA (or equivalent)

Since the last date for submission of online application forms had already expired on 14.06.2026, the University admission portal is hereby re-opened from 20.06.2026 to 29.06.2026 to enable candidates, who were earlier ineligible under the previous eligibility criteria, to apply.

Candidates who have already submitted their application forms need not apply again.

All other terms and conditions contained in *ibid* Admission Notifications dated 11.05.2026 & 26.05.2026 shall remain unchanged.


