In case a candidate fails to deposit the Counselling Fee of Rs 1000/- (non-refundable) and/or requisite prescribed annual fee, in full at the time of Counselling, he /she shall forfeit the selection /admission and the seat so forfeited shall be offered to the immediate next candidate in order of merit.
4. The seats shall be filled strictly as per prescribed eligibility in the order of merit.
5. No Under Process Certificate in respect of any requisite document will be entertained/ accepted under any circumstances.
6. Only complete requisite Qualifying Examination viz. UG for Master's Degree Programme shall be entertained.
7. No Date of Birth Certificate other than Matric 10th Class Certificate duly issued by Competent Board/University, shall be entertained.


