**Subject: Provisional Seat Allotment for Admission to B.Tech (AI in Agriculture)
Programme for Academic Session 2026-27 and Final Opportunity for
Submission/Correction of JEE (Mains)-2026-reg.**

NOTICE

In continuation of University Notification No.Au/Acad/U-09/2026/443-99 dated 13.04.2026 read with Notice No.Au/Acad/U-09/2026/5092-5130 dated 05.06.2026 & No.Au/Acad/U-09/2026/55297-5363 dated 10.06.2026 issued in connection with admission to the B.Tech (AI in Agriculture) Programme for the Academic Session 2026-27, it is hereby notified for information of all concerned candidates that:

The University Admission Portal shall remain open from **20.06.2026 (10.00 AM) to 22.06.2026 (11.59 PM)** for submission of JEE (Mains)-2026 score by those candidates who have not submitted the same earlier in pursuance of *ibid* office notices, which shall be the last and final opportunity for submission of the said score.

The portal shall also remain open during the aforesaid period for those candidates who have already submitted their JEE (Mains)-2026 score and wish to revise/correct the same due to any inadvertent error.

Candidates are advised to exercise due diligence while furnishing or revising their JEE (Mains)-2026 details. It shall be the sole responsibility of the candidate to ensure that the score/rank details submitted are correct, complete and pertain strictly to JEE (Mains)-2026 only. Submission of incorrect, incomplete, misleading or invalid particulars, including score(s) pertaining to any examination/session other than JEE (Main)-2026, shall be at the sole risk and responsibility of the candidate concerned. In such cases, candidature/admission, if granted, shall be liable to cancellation at any stage without prior notice, and no claim whatsoever shall be entertained by the University.

No request, representation or claim for consideration/allotment of seat(s), notwithstanding higher merit, shall be entertained thereafter on account of non-submission or incorrect submission of JEE (Mains)-2026 score within the stipulated timeline.

The provisional seat allotment for admission to the B.Tech (AI in Agriculture) Programme shall be made available on the University Admission Portal on **25.06.2026 (11.00AM)**, based on JEE (Mains)-2026 merit & the reservation/category status of the candidates.

Candidates shall login to their respective accounts on the University Admission Portal through their registered credentials to view their allotment status. The allotted candidates shall also be provided a payment link through the admission portal/e-mail for **non-refundable payment of Rs.11,000/-** (eleven thousand rupees only), comprising:

The candidate shall have to book the allotted seat by depositing the requisite fee through the aforementioned payment link only, from **25.06.2026 to 26.06.2026 (11:59 PM)**.

Any candidate failing to deposit the Seat Booking Fee within the stipulated timeline shall be deemed to have declined the offered seat, and the seat so allotted shall be treated as vacant.

The seat(s) falling vacant thereafter shall be offered strictly in order of merit to the next eligible candidate(s) through the University Admission Portal on **27.06.2026**. Such candidate(s) shall be required to confirm/book their seats by depositing the prescribed Seat Booking Fee up to **28.06.2026 (11:59 PM)**.

In case any seat(s) remain vacant thereafter, the same shall again be offered strictly in order of merit to the next eligible candidates through the University Admission Portal on 29.06.2026. Such candidates shall be required to confirm/book their seats by depositing the prescribed Seat Booking Fee up to 30.06.2026 (11:59 PM).

Candidates to whom seat(s) are offered in subsequent allotment(s) against vacancies shall be required to check their respective application/student dashboards on the University Admission Portal for allotment status and further instructions within the prescribed timelines. While the University may also communicate such allotment(s) through registered email, the same shall be only facilitative in nature. Non-receipt, delayed receipt or failure of email communication for any reason whatsoever shall not create any liability on the University nor confer any right upon the candidate for extension of time or reconsideration. Candidates are, therefore, advised to regularly monitor their application/student dashboards on the University Admission Portal for updates and further instructions in their own interest.

The balance fee, as per the fee structure applicable to the respective category of the candidate and already notified by the University, shall be deposited on the date of Document Verification-cum-Counseling. The Seat Booking Fee so deposited shall be adjusted against the total fee payable by the candidate at the time of admission.

The schedule and modalities for Document Verification-cum-Counseling for candidates who successfully confirm/book their seats shall be notified separately.

Note:


1. The provisional seat allotment shall remain subject to verification of documents/testimonials and fulfillment of the prescribed eligibility conditions for admission.

Any candidate who fails to substantiate the particulars furnished in the application form with valid documentary proof or is otherwise found ineligible shall forfeit his/her claim for admission, and the provisional allotment shall stand cancelled at the sole risk and responsibility of the candidate concerned.
3. The University reserves the right to conduct additional rounds of allotment/upgradation, if required, depending upon availability of vacant seats.
