- iii. To examine and propose any further changes, modifications, or additions deemed necessary for ensuring completeness, coherence, and alignment of the updated RRI prior to its finalization.


The Committee shall finalize and submit the updated and consolidated RRI document for consideration and approval of the Competent Authority by or before **15th June, 2026**.


