Notice

It is hereby notified for the information of all concerned candidates that, on the persistent demand of applicants, the preference/updation window for admission to BHT/BAT Diploma Courses for the Session 2026-27 is hereby re-opened from **20.06.2026 to 23.06.2026 (11:59 PM)**.

The facility shall be available to the following categories of candidates:

1. Candidates who have successfully applied for admission to BHT/BAT Diploma Courses but could not submit their preferences regarding District allocation and Course Selection within the stipulated time and are desirous of participating in the 2nd round of Counselling; and
2. Candidates who had already submitted their preferences and were also allotted seats in the first round of counselling but could not book/confirm their allotted seats, and are now willing to participate in the second round of counselling. Such candidates can also update their district allocation and Course preferences, if they so desire.

Accordingly, all eligible candidates falling under the above categories are advised to log in to their respective dashboards on the admission portal and submit/update their preferences within the prescribed period.

Candidates are advised to carefully review and finalize their preferences before submission, as the preferences exercised during this window shall be considered for subsequent seat allotment and no further opportunity for submission/updation of preferences may be provided thereafter.

The date for 2nd round of seat allotment and subsequent Document Verification/counselling shall be notified separately.
