



SPOT ADMISSION NOTICE

One-Year Basic Agriculture Training (BAT) and Basic Horticulture Training (BHT) Courses Academic Session 2026-27

Admission to the One-Year Basic Agriculture Training (BAT) and Basic Horticulture Training (BHT) Courses for the Academic Session 2026-27 was notified vide Admission Notification No.AU/Acad/BAT/BHT-2026/B-03(IV)/19861-99 dated 25.03.2026. Pursuant thereto, the admission process was conducted through the prescribed counselling procedure. Subsequently, an additional counselling round was also conducted to provide another opportunity to eligible candidates who had not participated in the earlier rounds.

Despite completion of the aforesaid admission process, certain seats have remained vacant. The University has also received representations from prospective candidates indicating that they could not participate in the admission process either because they had missed applying pursuant to the original notification or were unable to report during the notified counselling period. Considering the availability of vacant seats and with a view to ensuring optimum utilization of the available intake capacity while providing a final opportunity to eligible aspirants, it is hereby notified that **Spot Admissions** shall be conducted against the residual vacant seats in the BAT and BHT Courses for the Academic Session 2026-27 on the terms and conditions specified below:

1. Eligibility:

The candidate:

- a. Must be a domicile of the 'Kashmir Division' of UT of Jammu & Kashmir;
- b. Must have passed Matriculation (10th) examination from a recognized Board/University with a minimum of 40% aggregate marks;
- c. Must have attained the age of 17 years and must not be more than 30 years as on 31.12.2026.

2. Spot Admission Window:

From 10.08.2026 to 12.08.2026 during office hours or till exhaustion of available vacancies, whichever is earlier.

3. Mode of Admission:

The residual vacant seats shall be offered from a common pool, irrespective of their original district and category affiliation.

Admissions shall be granted on a **first-come-first-served** basis, subject to fulfillment of eligibility conditions, verification of original documents, availability of seats and payment of the prescribed fee.

4. Course Fee:

The course fee shall be **Rs.20,000/-** (Rupees Twenty Thousand only) per course, excluding charges towards transport, hostel, mess or any other institutional facilities, wherever applicable.

Additionally, Form fee of Rs.1000/- & spot counselling fee of Rs.1000/- (Total of Rs.2000/-) shall be charged.

5. Place of Reporting:

Eligible candidates desirous of seeking admission shall report in-person in the Academic Section of the Office of Registrar, SKUAST-Kashmir, Shalimar, Srinagar, along with original documents and the prescribed fee during the notified period.

Note:

The present Spot Admission window is a one-time arrangement for filling the residual vacant seats for the Academic Session 2026-27 only. The same shall not be construed as a modification of the University's reservation policy or district allocation framework. All seats shall revert to their original district-wise and category-wise status for future admission cycles.

The University reserves the right to regulate, modify or close the Spot Admission process at any stage. The decision of the University shall be final and binding on all concerned.

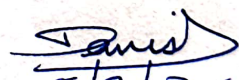
