Whereas, pursuant to the directions dated 02.06.2026 passed by the Hon'ble High Central Administrative Tribunal, Srinagar Bench, in OA No: 548/2026, titled "Mohd Abbas Joo Vs. Vice-Chancellor, SKUAST-K & Ors.", the representation of the applicant seeking implementtton of University Order No:234 (Est) of 2026 dated 02.04.2026 and permission of joining the duties, has been duly considered and examined in light of the applicable University policy, the relevant government instructions, and the records available on file: &

Whereas, upon examination, it has been found that the applicant fulfills the eligibility criteria prescribed under University Notification No:03 of 2018 dated July 07, 2018 and his case also been recommended by the duly constituted Committee and accepted by the Competent Authority, subject to the fulfilment of all mandatory conditions, governing the regularization; &

Whereas, Government Order No:528-JK(GAD) of 2021 dated 21.03.2021, mandates that a satisfactory Character and Antecedents Verification Report from CID, J&K shall precede the issuance of any formal orders of appointment of provisionally recommended candidate(s); &

Whereas, the Character & Antecedents Verification Report from received CID, J&K in respect of the applicant is adverse, indicating his involvement in case FIR No:97/2018 U/S 147,148,149,451,397-RPC 3 PPD Act of P/S Pattan, which stands challaned before the Competent Court and is presently subjudice; &

Now, therefore, after due consideration of the petitioner's case in compliance with the directions of the Hon'ble Court, it is ordered that although the applicant is otherwise eligible for regularization in terms of University Notification No:03 of 2018 dated July 07, 2018, no formal orders of regularization can presently be issued in his favour in view of the non-fulfilment of the mandatory requirement of a satisfactory Character & Antecedents Verification Report from CID, J&K, as prescribed by the Government Order No:528-JK(GAD) of 2021 dated 21.03.2021.
