Subject: Correction of name and parentage in service records of Mr. Altaf Yousuf Tankey, Ex-Works Supervisor, Estates Wing, SKUAST-K, Shalimar.

- Whereas, Mr. Altaf Yousuf Tankey, Ex-Works Supervisor, Estates Wing, SKUAST-K, Shalimar submitted a representation requesting correction of his name and parentage to be recorded as "Altaf Yousuf Tankey S/o Mohd Yusuf Tankey" in place of "Altaf Yusaf S/o M. Yusaf" in his official service records; &
- Whereas, as per the provisions contained in Circular No. FD-Code/154/2022-03 dated 10.05.2023 of Finance Department, Codes Section, Civil Secretariat, J&K, any government employee wishing to change their name must do so by executing a formal deed, publishing the change in a prominent local newspaper at their own expense, and ensuring the change is consistent with Aadhaar authentication and e-HRMS records; &
- Whereas, in compliance with the said circular, "Altaf Yousuf Tankey S/o Mohd Yusuf Tankey" executed the requisite deed and published the correction of his name and parentage in the leading newspaper, "The Daily Aftab Srinagar" on 17.07.2026, notifying the change from "Altaf Yusaf S/o M. Yusaf" to "Altaf Yousuf Tankey S/o Mohd Yusuf Tankey" and inviting objections therein within seven days, as required; &
- Whereas, No objections were received within the stipulated period; &
- Whereas, Altaf Yousuf Tankey also submitted a copy of his Aadhaar card reflecting his name as "Altaf Yousuf Tankey S/o Mohd Yusuf Tankey" as supporting document; &
- Whereas, the matter was submitted to the Competent Authority for consideration of the request of the official regarding correction of his name as "Altaf Yousuf Tankey S/o Mohd Yusuf Tankey" instead of "Altaf Yusaf S/o M. Yusaf" &
- Whereas, the Competent Authority has permitted the correction of his name as "Altaf Yousuf Tankey S/o Mohd Yusuf Tankey" instead of "Altaf Yusaf S/o M. Yusaf" in his service records for all official purposes.

Now, therefore, in view of the above, it is hereby ordered that henceforth the name and parentage of the official shall be recorded and reflected as "Altaf Yousuf Tankey S/o Mohd Yusuf Tankey" in place of "Altaf Yusaf S/o M. Yusaf", wherever appearing in the official records of the University.

All concerned sections shall make necessary corrections in the relevant records accordingly.

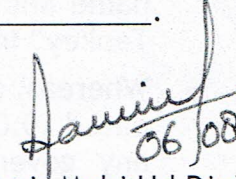
